## **MAYOR/COUNCILLOR ITEMS**

Council members brought forward the following items which were discussed:

- Councillor Wells advised that he is willing to work on the ice rink again this year and he hopes that some volunteers will assist. He is also willing to organize the games for Hilton Family Fun Day.
- Web Site we have been advised that the completion of the web site has been delayed and it will likely be January before the web site will be available.
- The recycled bottles/cans are being stored in the old shed at the dump which is deteriorating. A new 10 ft. x 10 ft. shed would cost approx. \$700 - \$1,000.
- It was noted that the revenue from the solar panels exceeds the annual loan payment.
- There is a ditch that was filled in by a resident on Sixth Street. Road Superintendent Tanya Alexander is to check it.
- A cost is to be obtained for repair of the holding tank at Forbes Park for budget.
- A clasp with a padlock is required for the ice rink shed.
- Councillor Wells agreed that the hose could be placed at the Waterfront Centre or the ice rink shed.

- The propane is to be checked for the ice rink shed.
- It was agreed that one small-sized shopping bag for personal purposes could be included inside the clear bag of household garbage. The clear bag policy which becomes effective January 1, 2016 will require education and flexibility over the first couple of months of implementation.
- The Marina suggestion boxes are to be checked. A Marina year-end operational and financial report is to be prepared.
- A letter of thanks is to be forwarded to Marina Manager John Walmsley for his excellent service.
- Road Superintendent Tanya Alexander is to check with Transfield regarding the timing of the culvert on Hwy. 548 next to Third Street and the ditching in that area is to be checked.
- Hilton Union Fire Department The proceeds from the recycled bottles/cans at the landfill have been placed in reserve for the firefighters for two years for a total reserve of \$4,353.48. Council agreed that it would be beneficial to establish a Hilton Union Library Improvement Fund using the proceeds from the recycled bottles/cans at the landfill since work is required to keep the Hilton Union Library in a serviceable condition for the benefit of both Township and Village ratepayers and it is a shared service.
- Use of Old Village Office by the Hilton Union Fire Department Council discussed the use of the old Village office by the Fire Department and they feel that the continued use is required as an interim measure until such time as a long term plan is finalized and implemented and until such time as an improved fire hall is available. The building is used for storage, it has a set up for training and most importantly, it provides access to all firefighters. Council agrees to reduce the fee for the use of the building from \$2,000 (which is split 50% Village/50% Township) to the cost of electrical use only (which is split 50% Village/50% Township) in the Fire budget.
