Council Meeting – March 10, 2016 7:00 p.m. – Council Chambers, Hilton Beach Municipal Office 3100 Bowker Street, Hilton Beach, Ontario

The meeting was called to order at 7:00 p.m. Present were Mayor Hope and Councillors Davey, Duma, and Moore. Councillor Wells was absent with notification.

DECLARATION OF PECUNIARY INTEREST

There were no declarations of pecuniary interest.

Jack Hore was present to discuss the signage at the Marina that is placed by the Snowmobile Club and wanted to ensure that Council is in agreement with the signage. It is suggested that more signs be placed to keep snowmobiles away from the docks and poles should be considered for each dock. This year, some have entered under the fishing pier bridge so there will be more signage placed in that area indicating 'No Entry'. Mr. Hore indicated that if there are any problems, he is willing to make further changes. The Village and Snowmobile Club can work together on this and add more signage where needed to reduce the possibilities of an accident. A copy of the Marina basin map is required and an agreement with the Club should be finalized to prevent problems in the marina basin. The Village will work with Mr. Hore to develop an agreement and signage plan.
