MINUTES

Council Meeting – September 14, 2016

The meeting was called to order at 7:00 p.m. Present were Mayor Hope and Councillors Davey, Moore and Wells. .

MINUTE OF SILENCE

- In Memory and to Honour former Clerk-Treasurer Gloria Fischer

There was a minute of silence in memory of and to honour former Clerk-Treasurer Gloria Fischer for her commitment and years of service with the Village.

DECLARATION OF PECUNIARY INTEREST

There were no declarations of pecuniary interest.

DELEGATIONS

1. Doug and Mary McRae re: snow plowing of Birch Street below Walnut Street

Mr. McRae advised that he would like Council to consider snow plowing Birch Street from Walnut Street to their driveway. They are planning to make their house on Birch Street their permanent home. They would only need a laneway opened and they do not feel there is a need for a turnaround as it would only be used by them. Mr. McRae noted that there is less of a slope than the remainder of Birch Street which washes out at times because of the loose gravel over pavement. Mayor Hope asked about the springs that run down the middle of the road. Mr. McRae advised that Road Superintendent Alexander had added some weeping tiles and it is now less wet. Councillor Davey noted that this is used as a trail by the Snowmobile Club and it could be a hindrance to snowmobiles if it is sanded. There was a discussion about a possible extension of Mariner's Way but it was not thought to be practical. There is a need to speak with some snow removal contractors who would know what may or may not work. Mayor Hope asked if he would be willing to pay towards the plowing but Mr. McRae did not feel that was reasonable given his assessment and taxes that are paid. Further discussions are required with the snowmobile club and snow plowing contractors as to ramifications and costs. Councillor Wells indicated that there would likely be problems, particularly when the snow is melting.

WHEREAS camping is about celebrating the great outdoors and is an integral part of our nation's history and our identity as Canadians;

AND WHEREAS nearly 5.8 million Canadians go camping each year, along with numerous international visitors who want to experience the natural wonder of our country;

AND WHEREAS campgrounds are active, labour-intensive, recreational, hospitality businesses that provide affordable vacationing option for middle-class Canadian families and international visitors with many campgrounds in Canada being family-run small businesses that have been around for generations;

AND WHEREAS campgrounds across Canada have begun receiving notices from the Federal Government warning them of reassessments as they are deemed to be too small to qualify for the small business tax deduction, because many family-run campgrounds do not have the required number of employees to qualify for the small business tax rate;

AND WHEREAS some family-run campgrounds will now be taxed at triple the rate of other small businesses – rates higher than even Canada's biggest billion dollar businesses, with penalties and interest, back tax bills will be in the tens of thousands of dollars, crippling otherwise healthy businesses, and leading to ruin for others;

AND WHEREAS the 2016 Federal budget abruptly concluded a promised 2015 review of these tax rules;

NOW THEREFORE the Council of the Village of Hilton Beach hereby respectfully urges the Federal government to set-aside these audits until the unclear and unfair application of these rules can be resolved;

AND FURTHER to do that, we require the federal government to recognize small, mostly family-run campgrounds as small businesses and pay the same tax rate as other small businesses.
