Please make sure ashes transported to the landfill are completely out! There is not only a danger in transporting hot ashes in your vehicle, but the hot ashes can also result in starting fires at the landfill site.

#### How to be lawn mower smart

In much of Canada, mowing the lawn is a mandatory summer chore for anyone with a front or back yard. Each year, Canadians are injured while using push mowers or riding mowers. Here are some tips to keep you safe.

Wear the Gear- Wear close fitting clothing, proper shoes or boots, eye and ear protection.

Look first- Make sure that people (especially children) and pets stay well back from the area being mowed. Check the lawn for rocks, sticks, toys and other potential projectiles before mowing. Be sure to look behind you before backing up.

Get trained- Read the owner's manual at the start of the season and review it periodically throughout the summer. Teach children of the hazards of the lawnmower and to not go near while in use. Do not give children (or adults) rides while using the riding lawn mower.

Drive sober- Alcohol and other substances impair your judgement, slow your reflexes and can result in poor decision making. Drive sober!

Other Tips- Make sure the mower is turned off (and unplugged, if electric) and the blades have stopped spinning before unclogging, cleaning or adjusting mower. Allow the engine to cool before refuelling the mower or touching the engine.
