- Speak with the Auditor to see if he would be able to meet with Council prior to June 14 and then again on June 14 for a public meeting.
- The spreadsheet showing the profits for Recreation should itemize the General Recreation Expense as it includes the projects completed by Recreation.
- Check on the distribution of costs by Algoma Health
- The plumber is to check the pipe under the library.
