MINUTES

Council Meeting – July 12, 2017

6:45 p.m. – Council Chambers, Hilton Beach Municipal Office 3100 Bowker Street, Hilton Beach, Ontario

The meeting was called to order at 7:00 p.m. Present were Mayor Hope and Councillors Moore, Wells, Bailey Meeks and Shaughnessy.

DECLARATION OF PECUNIARY INTEREST

There were no declarations of pecuniary interest.

DELEGATIONS

Doug Clute re: Bridge of Heroes project

Doug Clute advised that he has developed a Book of Remembrance that has information regarding the service members who lost their lives in World Wars I and II for the area including the Island, Laird, Tarbutt and Macdonald, Meredith and Aberdeen Additional. The Book is located in a cabinet at the Richards Landing Legion. Over the longer term, the legion would like to fly 28 white flags with 'Lest we Forget' on both sides of the Island bridge. They would also like to fly the Canadian Ensign, Union Jack and the Canadian Flag. They would place them on the bridge on the third week of October and remove them a day or two after Remembrance Day. Their request is that the Village contact the Ministry of Transportation to request that they incorporate the provision for placement of these flags in their design of the upcoming bridge project. The flag project cost is \$15,000 and the costs are expected to be paid by donation. He has spoken with the Gilbertson family and they are fully supportive of the proposal. MPP Mike Mantha also supports the project. There is a possibility that they will also have a bronze plaque in one of the park areas next to the bridge referencing the 56 fallen comrades. The Legion will be responsible for placing and removing the banners.

Darcy McIntosh re: outdoor wood furnace

Darcy McIntosh was present to request that he be permitted to place an outdoor wood furnace in the garage that they are proposing to build next to their house. They burn about 25 cord a year in their 200 year old house with no insulation. They would keep the stack high enough and behind the garage. Their existing chimney is about 15 ft. from ground level and the new one is proposed to be over 20 ft.

Mayor Hope asked if he has approached his neighbours. He noted that there have been legal issues in the past relating to outside furnaces as the soot and smoke infringe on the neighbours. Mr. McIntosh indicated that they are trying to place it at a higher level so it is away from others. Propane gas is not feasible as they would require a complete renovation with heat ducts and furnace. This proposal would be convenient and cost efficient. The unit would be completely enclosed in a room at the back of the garage and the back-supporting wall would hold the chimney stack. Council commented that there has been concern with their parking of trucks, etc. on the road. Mr. McIntosh advised that he will now have a garage so this should not happen in the future. With respect to insurance, it is not considered anything different than they have now.

Mayor Hope advised that more time is required to consider the request and a response would be made within seven days.
