# **DELEGATIONS**

7:00 p.m. - Michael Trainor, President, St. Joseph Island Lion's Club Re: Winter Community Hall Closure

Michael Trainor as well as two founding members Charles Nelson and Harold Daynard were present to discuss the community hall closure for the winter months. Harold Daynard advised that he and Charles have been with the Lion's Club for 46 years. In March 1986, they first began talking about the community hall upgrades and a feasibility study was prepared prior to the grant. They raised \$272,650 in addition to the \$137,000 grant. He commented that he is proud of the Hall and all of the work performed by the Lion's Club to make it possible. He mentioned that the tables need to be replaced in the Hall and that is something that they could possibly make happen. He is disappointed that the hall cannot remain open for the winter months. He provided some newspaper articles from when the upgrades were in progress.

Michael Trainor advised that the Lion's Club performs a yearly review of donations that they make to various organizations and they try to help when they can. He advised that the Pancake breakfasts will take place at the Royal Canadian Legion from Jan. – March, 2018. They have also made a change so that they go to local restaurants on the Island for their meetings rather than having them catered. They have seven new members. He agreed that they could consider tables but ultimately would like to do more work in the kitchen. Mayor Hope advised that the Village will re-evaluate over the winter months and it could re-open early depending on weather, etc. In terms of sanding during the winter months, Mike Trainor advised that no one can take on the liability other than the Village. It would be very difficult to close a pancake breakfast down when the weather turns bad as the organizers start early and others come from the Sault.

It was suggested that if there are projects or purchases that the Village would like to be considered by the Lion's Club, the Village should submit their request in writing. Their priority list moves all the time but in this way the items could be considered and a response provided.

Council reaffirmed the support and partnership for the Lion's Club and look forward to their return in April, 2018.

# MAYOR/COUNCILLOR ITEMS

The following items were discussed:

- Rubbermaid containers are required for utensils in the community hall kitchen. Pest control will be required in the spring;
- MTO is to be contacted in the spring to deal with the washouts being experienced to Ringham Street and the entrance to the Community Hall resulting from water not being directed properly down the hill;
- The dirt that has been piled in the ball diamond is to be removed;
- Consider a 'spring fling' dance to generate income for the hall;
- Consider Appreciation dinner;
- Three or four railings require repair along the entrance to the Post office an accessibility grant should be considered to provide better access for the future;
- Changes to Employment Standards Act, i.e. minimum wage, vacation pay, etc.
- Request for assistance with the ice rink;
- Long term planning a special meeting will be required to consider a 5 yr. and 25 yr. plan to include such items as promotion of the hall; marketing waterfront centre units; tourism attracting more people to the Village to live and to visit.
- Landfill requirements advise residents of issues that must be addressed as per Ministry direction;
- Further discussions regarding use of landfill address Ministry requirements as well as revenues.
