MISCELLANEOUS REPORTS

1. Report from Clerk-Treasurer

Items discussed were as follows:

• A proposal has been received to complete the stucco work on the Cenotaph as well as the pillars in the amount of \$20,300.00 plus taxes. The costs can be covered under the Main Street Revitalization Grant. Hilton Township is willing to put their grant towards this work and the Village is to decide how much they are able to put towards it. There will be further work required in addition to the proposal such as a new, wider sidewalk, restore the cement stairs, landscaping, lighting and other improvements. All of this work can be completed prior to Remembrance Day.

- It was agreed that the following works be established as an outline of the work that is being proposed under the Main Street Revitalization Grant:
 - o Cenotaph \$10,000;
 - O Streetscaping and landscape improvements lighting, banners, picnic tables, garbage/recycle containers, landscaping along the two main streets (along Marks Street and the marina), flower containers, etc. \$20,000;
 - o Signage for Waterfront Centre businesses \$1,000;
 - o Farmers' Market promotional advertising, way finding signage, other requirements \$6,796.80.
- Barrels have been purchased and placed around the tent to stabilize it in the winds. The market has been very successful so far this year with a large number of attendees and new vendors.
- The replacement culverts have been completed on Hwy.548 as well as the ditching. The pulverizing of the highway and surface treatment will be done in late August/early September. Village ditching along Birch Street is required to connect to the work done on Hwy. 548. Ditching along Oak Street for winter month access may also proceed subject to further review.
- Approval has still not been received from Algoma Power to place banners/flower pots on the hydro
 poles. Algoma Power is also discontinuing the placement of the banners over the highway for
 special events and community night. They have done it for years but will no longer do it. Further
 discussion should take place with Algoma Power on this matter.
- A curb stop broke on Marks Street and had to be replaced.
