# **MINUTES**

# Council Meeting – March 6, 2019

The meeting was called to order at 7:00 p.m. Present were Mayor Hope and Councillors Davison, Bailey Meeks and Moore. Councillor Wells was absent.

# **DECLARATION OF PECUNIARY INTEREST**

There were no declarations of pecuniary interest.

# **DELEGATIONS**

1. Tom Desjardin re: various issues

The snow banks should be pushed back with a grader as there will be no where for the water to go. He noted that there are hydrants that would be very difficult to access due to their location. There is a 5 ft. snow bank and then a 3 ft. ditch and the hydrant is on the other side of the ditch. This should be looked at over the summer and possibly a small culvert could be placed in those locations to be able to access them. Consideration should be given to relocating the propane tank at the Waterfront Centre as it is also difficult to access. The roof at the sewage treatment plant should be repaired during the summer months. Council should consider no overnight parking at the community hall and waterfront centre as it makes it more difficult to plow the snow. There should also be no parking on South Street. Council advised that they would consider the issues brought forward during budget deliberations so that any required work can be completed over the summer.

Mr. Desjardin also felt that MTO should be contacted regarding the mess that was left on Hwy. 548. Someone should be made accountable for the poor workmanship as it was clear that the surface treatment mixture was not good and it resulted in a waste of time and money. He also expressed concern regarding the large snow blower used by MTO at the bridge that blows piles of snow with salt and brine into the lake.
