- Contractors are to be contacted again re: drainage works required on Maple Street;
- Dana Stevens has a 99 year old maple tree that has been cut down. They are going to create slabs from it and asked if the Village would be interested. Council would be pleased to obtain one or two slabs, if possible.
- A boat was at the marina all summer but doesn't use power. However, they are charged for shore power. This is based on the rate schedule.
- Would it be feasible to move the Farmers' Market to the All-season surface as there would be better visibility and more parking. It was agreed to have a further discussion in January or February. In the meantime, Councillors Moore and Davison will brainstorm with the vendors.
- The brush pile at the landfill will be burnt during the next Fire practice;
- The diesel fuel tank is close to empty but in accordance with the Emergency Plan, fuel should be available over the winter months. It was agreed to purchase up to 5,000 litres.
- There are a couple of boats in the way for accessing the fuel pumps and need to be relocated. There are a couple of others that need to be relocated as well. Mayor Hope and Marina Manager McRae will work this out.
