2023 Budget is on track as we were able to make up revenue in some areas to cover cost overruns in others. Additional numbers still to be finalized. Complete budget picture will be available in time for the Budget/Finance Committee Meeting(s) in February/March 2024

12. Community Hall Expenses for 2023

Expenses for the Community Hall are increasing annually due, to the size, age and lack of upkeep of the building. Expenses for the Hall for 2023 will exceed \$60,000. Revenue generated by bookings has increased with an annual total of roughly \$3,500.

Since the Lions Club is the largest user group to benefit from the Hall, Mayor Hope and Councillor Delvecchio will approach them to discuss solutions. Municipal Staff will continue to look for funding opportunities.

13. Hilton Beach Community Events 2023 Current Special Event format is not manageable for Municipal Staff. At January's Council Meeting, Council will discuss possible changes and the creation of a Recreation Committee
