### MISCELLANEOUS REPORTS

1. Report from Maintenance Supervisor Elijah Lederman

There was a discussion regarding the work required for South Street and Maple Street. There is no consensus from contractors for an obvious solution for Maple Street. A French drain was considered but it was felt that the sand would clog it up too fast. If anything were done to the road itself, it would be expensive and would not likely be effective. Ditch and culverts may solve some of the problem but not all. The contractors indicate that they cannot guarantee that any of the proposals would work effectively. It was agreed to obtain prices for culverts and ditches around the church property, clean out ditches along Maple Street, place filter cloth and rip rap.

It was agreed to obtain quotes for South Street to ditch as much of the property in front of the Island Villa and have rip rap placed along the ditch. Council did not agree with a lengthy culvert in front of the Island Villa as it will clog up causing future drainage issues.

Further quotations are required regarding a truck as the original truck was not large enough to plow properly. Further quotes are also to be obtained for a trailer.

Further discussion is required regarding a new garage with costs being covered by a grant. Costs and benefits for a regular garage are to be compared with a quonset hut.

#### 2. Report from Clerk-Treasurer

Items discussed were as follows:

- The 2020 audit is being done remotely again this year;
- A date for the budget meeting has not been finalized;
- The 'Opinion of Value' for Park Lot 4 has not been finalized;
- The removal of scrap was discussed but not finalized.
- A preliminary budget meeting is scheduled for May 25, 2021 at 6 p.m.
- A number of complaints have been received regarding golf carts and 4-wheelers being in and around the Village and causing damage in the park. Residents should contact the O.P.P. if they have issues such as this. The more calls they receive, the more likely they will respond.

- Stop signs are to be reviewed.





# **Key Messages:**

- Check with your local municipal office or Ministry of Natural Resources for burning restrictions or bylaws before burning grass or brush around your cottage.
- ✓ Build campfires on bare soil or exposed rock, well sheltered from the wind. Keep a pail of water and a shovel on hand to control the fire.
- ✓ Douse campfires with water and stir the ashes with a stick or shovel to allow the water to soak in and cool the ashes and the ground.
- Campfires should never be left unattended and must be thoroughly extinguished before leaving the site.
- Extinguish cigarette butts by dousing them with water or crushing them thoroughly in bare mineral soil or on bare rock.
- ✓ Never discard a burning cigarette in the bush or from the window of a moving vehicle.
- ✓ Allow portable generators, stoves and lanterns to cool before refuelling. Refuel on bare soil or exposed rock.


